AGREEMENT

The following guidelines will apply to *Horse & Reader* programs:

- A. ATTENDANCE: Success starts with showing up! *Horse & Reader* addresses behaviors that foster success in school and in life. Your child is expected to attend every scheduled class. Program fees, less the non-refundable \$50 registration deposit, will not be refunded unless registration is cancelled at least one week before the program begins.
- B. SAFETY: Safety is critically important at J-Bar Ranch. When we say “safety,” we mean the physical and emotional safety of *all* humans and animals. We’ll teach the rules and expect a daily safety/responsibility pledge from participants. *We will instantly revoke participation of any person who knowingly endangers self, other participants, and/or animals by not following program rules.*
- C. WHAT TO WEAR: Proper clothing is an important part of staying safe at J-Bar Ranch and around horses. Long pants and boots are required during every *Horse & Reader* program. In addition, helmets (provided by J-Bar Ranch) are required while handling or riding horses. Long-sleeved shirts are recommended to limit sun exposure. Flip-flops, sandals, open-toed and open-heeled shoes, hanging belts, scarves, jewelry, wide bell-bottom pants, overly long pants, shorts, cut-offs, and capris are forbidden for students and for family members visiting J-Bar Ranch. If proper clothing will be a problem for your student, please contact J-Bar staff.
- D. TRANSPORTATION: It’s the responsibility of the parent/guardian or designated driver to provide on-time transportation to and from J-Bar Ranch for participating students. Please do not have your student at the ranch more than 15 minutes ahead of the start of class, and please do not be late in picking up your child. If you are participating in a carpool, you are required to have a responsible, approved adult waiting at the designated drop-off point to receive and supervise your child.
- E. PAYMENT: A non-refundable, \$50 deposit will be necessary with this form to hold a place for your child. The remainder of the program fee is due on or before the first day. Fees are payable via cash, check or credit card, using the PayPal button on our website.
